Administering Paper 2: questions

The optional English grammar, punctuation and spelling test can be administered during **May 2022**.

The confidentiality and integrity of the test must be maintained until **Wednesday 1 June**. The test must not be shared or made available outside your school before this date.

Please ensure you have read and understood the 2022 test administration guidance before administering the test.

For test administration

2022 key stage 1 English grammar, punctuation and spelling test

The key stage 1 English grammar, punctuation and spelling test consists of 2 papers. The papers must be administered in order. Pupils do not have to sit both papers on the same day. If both papers are administered on the same day, pupils may benefit from a break between papers. Both papers can be administered to the whole class, smaller groups of pupils or on an individual basis. All test materials, including unused test papers, must be stored securely until Wednesday 1 June.

Paper 2: questions

The following information explains how to administer the key stage 1 English grammar, punctuation and spelling test Paper 2: questions. If you have any questions, you should check with your headteacher or key stage 1 test co-ordinator before you administer the test.

Please follow these instructions correctly to ensure the test is properly administered.

Format	<ul style="list-style-type: none">● Paper 2: questions consists of a single test paper.● It is expected that Paper 2 will take approximately 20 minutes to complete, but it is not strictly timed.● It is at your discretion to choose when, or if, a pupil requires a break during the test or whether, if appropriate, to stop the test early.
Equipment	<p>Each pupil will need the equipment specified below:</p> <ul style="list-style-type: none">● a pencil or blue or black pen● a rubber (optional) <p>If rubbers are not provided, tell pupils that they should cross out any answers they wish to change. Highlighter pens may be used if this is normal classroom practice.</p> <p>Pupils are not allowed:</p> <ul style="list-style-type: none">● dictionaries● electronic spell checkers● bilingual word lists or electronic translators
Assistance	<ul style="list-style-type: none">● You must ensure that nothing you say or do during the test could be interpreted as giving pupils an advantage, for example, indicating that an answer is correct or incorrect, or suggesting the pupil look at an answer again.● You must not explain any subject-specific terminology. If any other word in a question is unfamiliar to pupils, you may explain it, or show them objects or pictures to help them understand.● You must not give alternative explanations, for example, explain 'commands' as 'instructions' or name punctuation.● There is no specific hearing impairment guidance for this test, but be careful when signing to ensure you do not convey information that could give pupils an advantage.● Guidance for administering the test to pupils with a visual impairment is contained in the relevant modified test pack.● The document 'Notes for readers in the English grammar, punctuation and spelling test', which can be found at www.gov.uk/government/publications/notes-for-readers-in-the-english-grammar-punctuation-and-spelling-test-short-answer-questions, gives examples of how to read particular types of question in Paper 2.● The examples below illustrate how to deal with some common situations. Question: I don't understand the question. Answer: Read the question again and underline the words that tell you what to do. Question: What does 'comma' mean? Answer: I can't tell you, but think hard and try to remember. We can talk about it after the test.

<p>Before the test begins</p>	<ul style="list-style-type: none"> Review the list of pupils with any particular individual needs, for example, pupils who may need support from a scribe, a reader or a transcript made at the end of the test. Read 'Notes for readers in the English grammar, punctuation and spelling test'.
<p>What to do at the start of the test</p>	<ul style="list-style-type: none"> Check seating is appropriately spaced and that no pupil can see another pupil's test paper. Check pupils do not have mobile phones or other disruptive items. Check pupils do not have any materials or equipment that may give them extra help. Ensure each pupil has a copy of Paper 2: questions.
<p>How to introduce the test</p>	<ul style="list-style-type: none"> It is important to brief pupils fully at the start of each test. Use these instructions to introduce Paper 2: questions. The wording of these instructions can be adapted, provided the meaning is retained. <p><i>This is the English grammar, punctuation and spelling test Paper 2: questions.</i></p> <p><i>The test will take around 20 minutes.</i></p> <p><i>You should have Paper 2: questions in front of you.</i></p> <p><i>Write your name on the front of your test paper.</i></p> <p><i>If you want to change an answer, you should rub it out or put a line through the answer you don't want to be marked.</i></p> <p><i>Now turn to page 3.</i></p> <p><i>There are 2 practice questions that we'll do together.</i></p> <ul style="list-style-type: none"> Read the question to the pupils. <ul style="list-style-type: none"> <i>Tick the sentence below that is punctuated correctly.</i> Then read the sentence. <ul style="list-style-type: none"> <i>The ball rolled across the playground.</i> <i>Tick one.</i> Give pupils the opportunity to answer the question in their booklet. If a pupil is not sure what to do, explain what they need to do to answer the question. Read the question to the pupils. <ul style="list-style-type: none"> <i>Look at where the arrow is pointing.</i> <i>What is the punctuation mark called?</i> Then read the sentence. <ul style="list-style-type: none"> <i>What a delicious cake we ate!</i> Direct pupils towards the options and then give them the opportunity to answer the question in their booklet. If any pupil is not sure what to do, explain what they need to do to answer the question.

<p>How to introduce the test (continued)</p>	<ul style="list-style-type: none"> ● Tell the pupils that: <i>There will be other types of question. If you are unsure how to answer, you should put up your hand to ask.</i> <i>You need to work on your own. You need to think of your own answers and you must not talk about them with anyone else.</i> <i>Try to answer all of the questions. If you can't answer a question, move on to the next one and come back to it later if you have time.</i> <i>Read each question carefully so you know what it is asking.</i> <i>Remember to check your work carefully.</i> <i>If you have any questions during the test, you should put your hand up and wait for someone to come over. Remember, we can't help you answer any of the test questions.</i> <i>Do you have any questions?</i> <i>Turn to page 4 and start the test.</i>
<p>How to deal with issues during the test</p>	<p>It is impossible to plan for every scenario. Whatever action you take, pupil safety must always be your first consideration.</p> <p>In the following circumstances, you will need to stop the test either for an individual pupil or for the whole cohort:</p> <ul style="list-style-type: none"> ● test papers are incorrectly collated or the print is illegible ● an incorrect test has been administered ● a fire alarm goes off ● a pupil is unwell ● a pupil needs to leave the room ● a pupil is caught cheating <p>If you need to stop the test:</p> <ul style="list-style-type: none"> ● make sure the pupils are kept under test conditions and that they are supervised ● if the pupils have to leave the room, ensure they do not talk about the test ● speak to your test co-ordinator or a senior member of staff for advice on what to do next ● consider contacting the national curriculum assessments helpline on 0300 303 3013 for further advice <p>You should brief your headteacher on how the incident was dealt with once the test is over.</p>
<p>What to do at the end of the test</p>	<ul style="list-style-type: none"> ● Follow your school's procedure for collecting and storing the pupils' test scripts. ● All test materials, including unused test papers, must be stored securely until Wednesday 1 June. ● If you need to make a transcript of a test script, complete it with the individual pupil at the end of the test under test conditions. Particular care should be taken to ensure accurate transcriptions are made and the pupil's answers, including spelling, are not corrected or amended.
<p>Marking the test</p>	<ul style="list-style-type: none"> ● Use the key stage 1 test mark schemes to mark the test, following both the general guidance and any specific guidance for each question.
